ORDINANCE NO. 19 21

AN ORDINANCE AMENDING CHAPTER 21, ARTICLE 4, OF THE HAWAI‘I COUNTY CODE 1983 (2016 EDITION, AS AMENDED), RELATING TO SEWER SERVICE CHARGES.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF HAWAI‘I:

SECTION 1. Purpose. The purpose of this ordinance is to increase wastewater service charge rates to cover the costs of providing those services. These increases will reduce the Wastewater Division’s dependence on the General Fund and provide for improved maintenance and repair of the facilities.

SECTION 2. Chapter 21, article 4, Section 21-36.1, of the Hawai‘i County Code 1983 (2016 edition, as amended) is amended to read as follows:

“Section 21-36.1. Wastewater service charge rates.

[Sewer user charges for customers connected to gang cesspools shall be effective August 1, 2000, and sewer service charges paid prior to the effective date shall be reimbursed or credited. Sewer charges not paid prior to the effective date shall be waived.


